CALLS FOR PROPOSALS

Attraverso i programmi europei a gestione diretta, l'UE sostiene finanziariamente lo sviluppo di progetti che contribuiscono a realizzare gli obiettivi politici della Commissione per la programmazione 2021-2027. Tali programmi prevedono specifiche **call for proposals** pubblicate e gestite direttamente dalla Commissione europea e dalle sue Agenzie esecutive. Ciascun programma può prevedere regole di candidatura distinte e anche le modalità di gestione e rendicontazione delle attività realizzate e delle relative spese possono essere diverse.

EU4Health: 2024 calls for proposals - crisis preparedness

The European Health and Digital Executive Agency (HaDEA) has published four new calls for proposals addressing "crisis preparedness", in collaboration with Health Emergency Preparedness and Response Authority (HERA), to support response readiness for future health emergencies, with a focus on priority pathogens with pandemic potential. With a total budget of 149.000.000 €, it includes the following topics:

Funding programme: EU4 Health Programme (EU4H)

Deadline: 5th September 2024

Applicants: legal entities (national authorities, health organisations and other relevant bodies) established in EU Member States or EU4Health Programme associated countries

Activity sectors: health

Partnership: depending on specific topic requirements

Interregional Innovation Investments (I3) Instrument 2024 calls for proposals

The European Commission launched two new Interregional Innovation Investment (I3) Instrument calls, with a budget of 67 million €.

These calls target consortia of innovation actors from regions with complementary smart specialisation areas, willing to make investments in interregional innovation projects ([Strand 1](#)), and support projects aiming at developing value chains in less developed regions and reinforcing the integration of innovation actors in EU value chains ([Strand 2a](#)).

Funding programme: Horizon Europe and European Regional and Development Fund (ERDF)

Deadline: 5th December 2024

Applicants: legal entities (public or private bodies) established in EU member states or I3 associated countries

Activity sector: Digital transition, Green transition, Smart manufacturing

Partnership: consortia must consist of a minimum of three to five independent legal entities from diverse regions

CASCADE FUNDING

Il supporto finanziario a parti terze o “cascade funding” è un meccanismo di finanziamento della Commissione europea attraverso cui il consorzio beneficiario è incaricato di distribuire sovvenzioni ad entità terze attraverso le cosiddette “open calls”. Accedere a una sovvenzione derivante da una open call consente di ricevere un finanziamento pubblico per eseguire specifiche attività di ricerca e innovazione (studi, esperimenti, azioni pilota) senza dover incorrere negli oneri burocratici delle tradizionali call for proposals. Nella presente sezione sono riportate anche le call pubblicate nell’ambito delle KICs (Knowledge and Innovation Communities) dello European Institute of Innovation and Technology (EIT).

Supporting the innovation and internationalisation of European small and medium-sized enterprises in the defence sector (LEVIATAD second open call)

This call aims at supporting innovation, internationalization, and twin transition of SMEs with projects addressing the following priorities of the naval, aero-naval and defence sector: autonomous ships and drones, communication and cybersecurity, on-board equipment development and performance improvement, predictive maintenance, weapon systems improvement, decarbonization of ships. The applicants can receive up to 20.000 € in lump sums.

Deadline: August 8th 2024

Applicants: SMEs and start-ups established in EU Member States and members of an international or national organization (cluster, platform, chamber of commerce, guild or similar) that promotes naval and aero-naval defence industry

Activity sectors: innovation, internationalisation and twin transition

Partnership: not required

CORTEX2 Open Call #2

CORTEX² Open Call #2 will invest a total of 1.000.000 €, aimed at recruiting tech start-ups/SMEs and/or research organisations to co-develop the CORTEX² platform. The objective is to deliver an inclusive XR teleconference platform while involving organisations in the 'Lab-To-Market' stage that will bring new modules and features, enhancing the functionalities and opportunities CORTEX2 can provide.

Deadline: August 15th 2024

Applicants: Tech start-ups, SMEs, Research organisations, and Tech developers

Activity sectors: extended reality

Partnership: optional (single applicants or small consortia of maximum 2 entities)

FORTHCOMING

Horizon Europe: Development of next generation synthetic renewable fuel technologies

This call aims at supporting projects for the development of next generation technologies for the production of novel synthetic renewable liquid and gaseous fuels from CO₂, and/or renewable carbon, nitrogen, hydrogen or their compounds, and from renewable energy. Activities are expected to achieve TRL 3-4 by the end of the project. Total call budget 12.000.000 €; indicative number of grants: 3.

Planned opening date: September 17th 2024

Deadline: January 21st 2025

Applicants: legal entities (public or private bodies) established in EU Member States or associated countries

Activity sector: renewable fuels

Partnership: required (at least 3 independent legal entities established in different EU Member States or Horizon Europe associated countries)
