CALLS FOR PROPOSALS

*Attraverso i programmi europei a gestione diretta, l'UE sostiene finanziariamente lo sviluppo di progetti che contribuiscono a realizzare gli obiettivi politici della Commissione per la programmazione 21-27. Tali programmi prevedono specifiche **call for proposals** pubblicate e gestite direttamente dalla Commissione europea e dalle sue Agenzie esecutive. Ciascun programma può prevedere regole di candidatura distinte e anche le modalità di gestione e rendicontazione delle attività realizzate e delle relative spese possono essere diverse.*

EIT Manufacturing Call for Innovation proposals 2025

The call aims at fostering innovation within the manufacturing sector, by addressing industrial key-challenges, and facilitating a transition towards more resilient, sustainable, and human-centered

manufacturing practices. It focuses on leveraging cutting-edge technologies and methodologies. Innovation activities on the following topics will be funded with a total call budget of 11.000.000 €:

- Topic 1: Innovative Solution for Industrial Challenges;
- Topic 2: Transition towards a resilient and human-centered manufacturing.

Funding programme: Horizon Europe – European Institute of Innovation and Technology

Call & Topic ID: 2nd EIT Manufacturing Call 2025 for Innovation proposals

Deadline: July 8th 2024

Applicants: legal entities from EU and non-EU associated and non-associated countries

Activity sector: advanced manufacturing

Partnership: required (at least 3 legal entities established in different countries; of which at least 1 from an EU Member State)

Horizon Europe: EU Missions Calls for Proposals

The five EU Missions are a novelty of the Horizon Europe research and innovation programme (2021-2027). They support EU transformation into a greener, healthier, more inclusive, and resilient continent, according to the European Commission's priorities. Each mission operates through a portfolio of actions, including the following calls for proposals:

Applicants: legal entities (public or private bodies) established in EU Member States or associated countries

Activity sectors: research and innovation

Partnership: required (at least 3 independent legal entities established in different EU Member States or Horizon Europe associated countries)

CASCADE FUNDING

Il supporto finanziario a parti terze o "cascade funding" è un meccanismo di finanziamento della Commissione europea attraverso cui il consorzio beneficiario è incaricato di distribuire sovvenzioni ad entità terze attraverso le cosiddette "open calls". Accedere a una sovvenzione derivante da una open call consente di ricevere un finanziamento pubblico per eseguire specifiche attività di ricerca e innovazione (studi, esperimenti, azioni pilota) senza dover incorrere negli oneri burocratici delle tradizionali call for proposals. Nella presente sezione sono riportate anche le call pubblicate nell'ambito delle KICs (Knowledge and Innovation Communities) dello European Institute of Innovation and Technology (EIT).

E-BOOST: Supporting innovative Products & Services development in electromobility sectors (Zero Emission Vehicles)

E-BOOST supports high-profile start-ups and SMEs by funding innovation projects addressing unmet needs in the electromobility sector. Applicants are entitled to benefit from more than one type of E-BOOST Lump sums with a combined maximum funding of 60.000 €/ beneficiary. This call offers up to 20.000 €/single applicant and up to 40.000 €/ consortium for respectively low-risk and high-risk innovation projects.

Deadline: July 1st 2024

Applicants: SMEs from the electromobility sector, based in a EU Member State or in a Single Market Programme associated country

Activity sectors: mobility

Partnership: optional (proposals can be submitted individually or jointly by a consortium)

XR4ED Open Call

The objective of the XR4ED - Open Call is to catalyze innovation and excellence in XR technologies for education while providing financial and technical support to start-ups, SMEs, industry players, and

education-focused actors. The open call is structured in two tracks – Call for Developers and Call for Pilots – and will fund a total of 20 projects, 10 in each call, with a total call budget of 4.600.000 €.

Deadline: July 1st 2024

Applicants: Start-ups, SMEs, Universities and Vocational and educational training (VET) organisations, operating in the XR sector and established in EU Member States or Horizon Europe associated countries

Activity sectors: Extended Reality (XR)

Partnership: required only for call for pilots (consortia must be SME-led)

FOODITY - Open Call #2

The objective of the FOODITY - Open Call #2 is to fund innovative data-driven solutions for food and nutrition respectful of users' personal data sovereignty. Applicants must develop a solution that addresses one of the following areas – shopping experiences, education, or services – within the domains of nutrition and food systems. Beneficiaries may receive up to 180.000 € and qualify for the FOODITY Star Award valued at 7.500 €.

Deadline: July 10th 2024

Applicants: SMEs, Social innovation actors (SIA), Research and technology organisations (RTOs), universities, and training organisations

Activity sectors: agri-food

Partnership: required (SME-led consortia of 2-3 entities, including either research and technology organisations, universities, social innovation actors, or training organisations)

FORTHCOMING

Horizon Europe: Marie Skłodowska-Curie Actions (MSCA) Doctoral Networks 2024

MSCA Doctoral Networks will implement doctoral programmes, through partnerships among universities, research institutions, and research infrastructures, businesses including SMEs, and other socio-economic actors from different countries across Europe and beyond. Through Industrial Doctorates, doctoral candidates will step outside academia and develop skills in industry and business by being jointly supervised by academic and non-academic organisations.

Planned opening date: May 29th 2024

Deadline: November 27th 2024

Applicants: academic and non-academic organisations (including companies)

Activity sector: multiple research/industrial fields

Partnership: required (at least 3 independent legal entities established in different EU Member States or Horizon Europe associated countries)
