## **CALLS FOR PROPOSALS**

Attraverso i programmi europei a gestione diretta, l'UE sostiene finanziariamente lo sviluppo di progetti che contribuiscono a realizzare gli <u>obiettivi politici</u> della Commissione per la programmazione 21-27. Tali programmi prevedono specifiche **calls for proposals** pubblicate e gestite direttamente dalla Commissione europea e dalle sue Agenzie esecutive. Ciascun programma può prevedere regole di candidatura distinte e anche le modalità di gestione e rendicontazione delle attività realizzate e delle relative spese possono essere diverse.

# Horizon Europe: End user-driven application of Generative Artificial Intelligence models in healthcare (GenAl4EU)

This call aims at advancing and generating research to better understand and improve Generative AIbased virtual assistant solutions and their applicability in healthcare settings, by improving patient health outcomes, fostering personalised healthcare and support the resilience, sustainability, and efficiency of the healthcare systems. The total budget allocated is €40.000.000

# Horizon Europe: Accelerate the uptake of life-cycle assessment (LCA) for Safe and Sustainable by Design (SSbD) chemicals and materials and resulting products (RIA)

This call targets projects aimed at supporting the implementation of EU strategies accelerating the lifecycle assessment. Proposals should identify and fill the gaps in LCA tools, methods and data used for improving the environmental sustainability and efficiency of chemicals, materials and resulting products, taking also into account the criticality of raw materials. All stages from raw material extraction to end-oflife disposal of products should be included. Projects should build on, or seek collaboration with, existing projects and develop synergies with other relevant European, national or regional initiatives, funding programmes and platforms. The total budget allocated is €15.000.000.

# **CASCADE FUNDING**

Il supporto finanziario a parti terze o "cascade funding" è un meccanismo di finanziamento della Commissione europea attraverso cui il consorzio beneficiario è incaricato di distribuire sovvenzioni ad entità terze attraverso le cosiddette "open calls". Accedere a una sovvenzione derivante da una open call consente di ricevere un finanziamento pubblico per eseguire specifiche attività di ricerca e innovazione (studi, esperimenti, azioni pilota) senza dover incorrere negli oneri burocratici delle tradizionali call for proposals. Nella presente sezione sono riportate anche le call pubblicate nell'ambito delle KICs (Knowledge and Innovation Communities) dello European Institute of Innovation and Technology (EIT).

## Women TechEU Open Call #4

The Women TechEU project supports early-stage deep-tech startups led by women, aiming to address the gender gap in the tech industry and foster a more diverse startup ecosystem across Europe. It enhances the competitiveness of companies tackling critical societal challenges and empowers women entrepreneurs to grow their ventures. The total available budget is €3.000.000, with up to €75.000 allocated to each startup.

Deadline: August 4th 2025

Applicants: early-stage deep tech start-ups established in an EU Member State or Horizon Europe Associated Countries, founded or co-founded by women, holding a top management position (CEO, CTO or equivalent).

Activity sector: deep-tech Partnership: not required

# CloudCamp4SMEs

CloudCamp4SMEs is a project co-funded by the European Union under the Digital Europe Programme aimed at providing SMEs with access to high-quality, low-cost training courses focusing on high-demand digital skills for Cloud Technologies Solutions. The training includes 2 managerial and 5 technical learning paths, with content delivered by global leaders in cloud technology to support the digital transformation of SMEs across the EU. Through this opportunity, SMEs can access a tailor-made training programme, which includes the CC4SME certification exam, a mentoring programme, AWS certification, as well as workshops and networking events.

Applicants: SMEs located in targeted EU countries (Denmark, Germany, Italy, Spain, and Poland)

The IHI partnership has published draft regarding the upcoming topics for Call 11, a two-stage call scheduled for launch in June 2025. The following topics are currently under consideration for inclusion in IHI call 11:

- Towards precision medicine: platform for transdiagnostic stratification of brain dysfunction;
- Understanding how infections foster and induce non-communicable diseases;
- Al-powered signal detection in pharmacovigilance;
- Leveraging Europe's expertise to accelerate cell therapy for type 1 diabetes:
- Establishing ortho and cardiology ambulatory surgical centres in Europe.
