CALLS FOR PROPOSALS

Attraverso i programmi europei a gestione diretta, l'UE sostiene finanziariamente lo sviluppo di progetti che contribuiscono a realizzare gli <u>obiettivi politici</u> della Commissione per la programmazione 21-27. Tali programmi prevedono specifiche **call for proposals** pubblicate e gestite direttamente dalla Commissione europea e dalle sue Agenzie esecutive. Ciascun programma può prevedere regole di candidatura distinte e anche le modalità di gestione e rendicontazione delle attività realizzate e delle relative spese possono essere diverse.

Horizon Europe: Chips Joint Undertaking - Calls 2025

The Chips Joint Undertaking (Chips JU) aims to bolster Europe's semiconductor industry by fostering collaboration between the EU, member states, and private sector. The Chips JU is currently selecting projects for the Electronic Components and Systems Research and Innovation (ECS R&I) calls. The total budget allocated is €231.000.000. At the moment, 6 open calls have been published:

- Global Innovation Action (IA)
- Heterogeneous Integration for High-Performance Automotive Computing
- RISC-V Automotive Hardware Platform
- Al-assisted Methods and Tools for Engineering Automation
- Global Research and Innovation Actions (RIA)
- Boosting R&I cooperation between EU and Japan on semiconductors

Funding Programme: Horizon Europe – Chips JU Call & Topic ID: HORIZON-JU-CHIPS-2025

Deadline: April 29th / September 17th 2025 (depending on the call)

Applicants: legal entities (public or private bodies) established in EU Member States or Horizon

Europe associated countries *Activity sector:* semiconductors

Partnership: required (at least 3 independent legal entities established in different EU Member States

or Horizon Europe associated countries)

Horizon Europe: EIC Pathfinder Open

The EIC Pathfinder Open supports early-stage development of high-risk, high-impact innovations with the potential to create new markets or industries. The call focuses on cutting-edge science and technology with the goal to develop breakthrough innovations. Expected outcomes include the advancement of radically new ideas and concepts. Activities should start at TRL 1 and aim to reach TRL 3 by the end of the project. The total budget allocated is €150.000.000

Funding programme: Horizon Europe – European Innovation Council

Call & Topic ID: HORIZON-EIC-2025-PATHFINDEROPEN

Deadline: May 21st 2025

Applicants: legal entities (public or private bodies) established in EU Member States or Horizon Europe

Horizon Europe: EuroHPC JU - International Collaboration on AI Factories and HPC-AI

The EuroHPC Joint Undertaking (EuroHPC JU) aims to enhance Europe's high-performance computing and data infrastructures, facilitating research and innovation across various sectors. The EuroHPC JU is currently selecting projects for a Coordination and Support Action to actively participate in the organisational and technical activities of the Trillion Parameter Consortium (TPC). Proposals should demonstrate a clear link with the TPC, aiming at creating extreme - scale state-of-the-art trustworthy and reliable generative AI models and to address and discuss the related key challenges to support the advancing of AI for science using HPC. The total budget allocated is €1.500.000.

Funding Programme: Horizon Europe – EuroHPC JU Call & Topic ID: HORIZON-JU-EUROHPC-2025-INCO-01

Deadline: June 4th 2025

Applicants: legal entities (public or private bodies) established in EU Member States or Horizon Europe associated countries

Partnership: required (at least one legal entity established in a Member State; and at least two other independent legal entities, each established in different Member States or Associated Countries)

CASCADE FUNDING

Il supporto finanziario a parti terze o "cascade funding" è un meccanismo di finanziamento della Commissione europea attraverso cui il consorzio beneficiario è incaricato di distribuire sovvenzioni ad entità terze attraverso le cosiddette "open calls". Accedere a una sovvenzione derivante da una open call consente di ricevere un finanziamento pubblico per eseguire specifiche attività di ricerca e innovazione (studi, esperimenti, azioni pilota) senza dover incorrere negli oneri burocratici delle tradizionali call for proposals. Nella presente sezione sono riportate anche le call pubblicate nell'ambito

delle KICs (Knowledge and Innovation Communities) dello European Institute of Innovation and Technology (EIT).

JARVIS Open Call #1

JARVIS Open Call supports European entities aiming to pilot solutions in human-robot collaboration. It targets SMEs, startups, and technology adopters (end users). The call is organised around two core pillars and an open topic, each addressing specific challenges to drive innovation and efficiency:

- Agile manufacturing;
- Al Enhanced Inspection and Maintenance.

The total budget available to finance 8 projects is €1.040.000. Budget per project: up to 130.000€.

Deadline: May 5th 2025

Applicants: IT technology providers (SMEs/start-ups), research organizations, industry technology adopters

Activity sectors: IoT, Edge, Cloud, or related technologies

Partnership: required (2-3 organisations, including a mandatory Technology Adopter/End-user and a

Technology Developer/Integrator - SME or start-up)

EIT-KIC Food: Fast Track to Market 2025

The EIT Food Fast Track to Market provides non-dilutive funding, mentorship, and market entry guidance to food tech start-ups looking to scale. It aims to accelerate the commercialization of innovative food technologies. Applicants for the Fast Track to Market 2025 call must have a product or solution aligned with EIT Food's missions.

Deadline: May 6th 2025

Applicants: small companies (less than 49 employees, less than €10 million in turnover, and at least 3 full-time employees) established in an EU Member State or Horizon Europe-associated countries

Activity sectors: Agri-food-tech Partnership: not required

LIFE Calls for proposals 2025

The LIFE programme is the EU's funding instrument for the environment and climate action. For the period 2021-2027, the programme is managed by the European Climate, Infrastructure and Environment Executive Agency (CINEA) and has a budget of €5.4 billion. It is divided into four sub-programmes:

- Nature and biodiversity
- Circular economy and quality of life
- Climate change mitigation and adaptation
- Clean energy transition

All LIFE Calls for proposals 2025 are expected to be published on the Funding & tender opportunities portal on 24 April.

Applicants: legal entities established in different EU Member States or LIFE Programme associated countries

Activity sectors: nature and biodiversity; circular economy, climate change mitigation; clean energy transition
