CALLS FOR PROPOSALS

Attraverso i programmi europei a gestione diretta, l'UE sostiene finanziariamente lo sviluppo di progetti che contribuiscono a realizzare gli obiettivi politici della Commissione per la programmazione 2021-2027. Tali programmi prevedono specifiche **call for proposals** pubblicate e gestite direttamente dalla Commissione europea e dalle sue Agenzie esecutive. Ciascun programma può prevedere regole di candidatura distinte e anche le modalità di gestione e rendicontazione delle attività realizzate e delle relative spese possono essere diverse.

Horizon Europe: Designing inclusive, safe, affordable and sustainable urban mobility

In line with the implementation plan of the Cities Mission, actions envisaged by this topic will provide a strong and direct support to cities that will commit to climate neutrality and enable them to roll out their climate action plans and achieve climate neutrality by 2030, in synergy with significant progress towards zero pollution. In turn, the cities benefitting from these actions will act as experimentation and innovation hubs for other cities to become climate-neutral by 2050.

Funding programme: Horizon Europe – EU Missions

Call & Topic ID: Research and Innovation actions for support the implementation of the Climate-neutral and Smart Cities Mission (HORIZON-MISS-2022-CIT-01)

Deadlines: September 6th 2022

Applicants: legal entities (public or private bodies) established in EU Member States or associated countries

Activity sector: sustainable urban mobility

Partnership: required (at least 3 independent legal entities established in different EU Member States or Horizon Europe associated countries)

LIFE: Supporting the clean energy transition of the business sector

In line with the need of accelerating the transition of EU companies towards a sustainable growth model and phasing out EU dependence on fossil fuels imports, facilitating the clean energy transition of EU companies through a larger uptake of energy audits and collaborative approaches has the potential to sensibly reduce EU fuels imports. The overall objective of this topic is to boost the market uptake of cost-effective energy efficiency measures and - where relevant - renewables and heat pumps among EU companies, by means of implementing energy audits suggested measures OR through the engagement into sustainable value chain business models.

Funding programme: LIFE Programme

Call & Topic ID: Life Clean Energy Transition (LIFE-2022-CET-BUSINESS)

Deadlines: November 16th 2022

Applicants: legal entities (public or private bodies) established in EU Member States or associated countries

Activity sector: clean energy transition

Partnership: required (at least 3 applicants – beneficiaries, not affiliated entities - from 3 different eligible countries)

CASCADE FUNDING

Il supporto finanziario a parti terze o “cascade funding” è un meccanismo di finanziamento della Commissione europea attraverso cui il consorzio beneficiario è incaricato di distribuire sovvenzioni ad entità terze attraverso le cosiddette “open calls”. Accedere a una sovvenzione derivante da una open call consente di ricevere un finanziamento pubblico per eseguire specifiche attività di ricerca e innovazione (studi, esperimenti, azioni pilota) senza dover incorrere negli oneri burocratici delle tradizionali call for proposals.

ONTOCHAIN Open Call 3 - Application and experimentation

Through this open call, ONTOCHAIN will select: a) Up to 3 projects to complete the missing blocks of the ONTOCHAIN infrastructure; b) Up to 11 projects to exploit the ONTOCHAIN infrastructure, designed and implemented respectively through ONTOCHAIN OC1 and ONTOCHAIN OC2, for real life use cases, that cover real need of individuals in terms of trustworthy data/services exchange and trustworthy content handling, from various vertical domains/vital sectors of the European economy.

Deadline: July 25th 2022

Applicants: team of individuals or legal entities (SMEs, universities, research centres, NGOs, foundations);

Activity sector: blockchain technologies

Partnership: not required

Get digital: Go Green & Be Resilient - Call for expression of interest

The project "Get digital, go green & resilient" aims to promote innovative digital solutions ‘made in Europe’ and help further mainstream them, including by helping uncover and address remaining barriers to digitalisation. The idea is to help create an EU-wide catalogue of digital use cases, with a focus on sustainability and resilience and to support the EC with a more concrete identification of barriers. Selected companies will present their solutions at one of the two workshops (one more focused on sustainability and one on supply chain resilience) - expected to be held in October/November 2022, and receive support and coaching services.

Deadline: August 31st

Applicants: SMEs from the EU, as well as from Ukraine, Moldova and Georgia

Activity sector: digital technologies
Partnership: not required

EIC Pathfinder Challenges aim to build on new, cutting-edge directions in science and technology to disrupt an existing market or create new opportunities by realising innovative technological solutions grounded in high-risk/high-gain research and development. Specific challenges:

- Cardiogenomics
- Carbon dioxide and Nitrogen management and valorisation
- Towards the Healthcare Continuum: technologies to support a radical shift from episodic to continuous healthcare
- Alternative approaches to Quantum Information Processing, Communication, and Sensing
- Mid to long term and systems integrated energy storage
- DNA-based digital data storage

Funding programme: Horizon Europe – European Innovation Council
