CALLS FOR PROPOSALS

Attraverso i programmi europei a gestione diretta, l'UE sostiene finanziariamente lo sviluppo di progetti che contribuiscono a realizzare gli <u>obiettivi politici</u> della Commissione per la programmazione 21-27. Tali programmi prevedono specifiche **calls for proposals** pubblicate e gestite direttamente dalla Commissione europea e dalle sue Agenzie esecutive. Ciascun programma può prevedere regole di candidatura distinte e anche le modalità di gestione e rendicontazione delle attività realizzate e delle relative spese possono essere diverse.

Interreg Central Europe: Strategic call for capitalization

Interreg Central Europe promotes transnational cooperation to make regions greener, smarter, and more interconnected. The call aims to enhance and expand the impact of existing Interreg Central Europe

projects by reducing cross-border barriers that hinder economic, institutional, and territorial flows, and by fostering greater cohesion and functional interconnection among regions through joint local and regional actions that actively involve relevant stakeholders. Project proposals can be submitted under four <u>programme priorities</u> and nine specific objectives. The total budget allocated is €23.000.000, with up to €1.250.000 per project.

The call aims to encourage the development and dissemination of innovative tools and business models to improve the visibility, availability, audience, and diversity of European works in the digital age, while fostering the competitiveness and the green and digital transition of the European audiovisual industry. The total budget allocated is €10.500.000.

CASCADE FUNDING

Il supporto finanziario a parti terze o "cascade funding" è un meccanismo di finanziamento della Commissione europea attraverso cui il consorzio beneficiario è incaricato di distribuire sovvenzioni ad entità terze attraverso le cosiddette "open calls". Accedere a una sovvenzione derivante da una open call consente di ricevere un finanziamento pubblico per eseguire specifiche attività di ricerca e innovazione (studi, esperimenti, azioni pilota) senza dover incorrere negli oneri burocratici delle tradizionali call for proposals. Nella presente sezione sono riportate anche le call pubblicate nell'ambito delle KICs (Knowledge and Innovation Communities) dello European Institute of Innovation and Technology (EIT).

FIERCE: Call 1# for advisory services

FIERCE initiative, under the Horizon Europe Framework, focuses on accelerating the adoption of downstream space data and services by SMEs. The call aims to drive innovation for the green and digital transition by offering support through advisory services to strengthen SMEs in designing, developing, or enhancing green solutions. These solutions should focus on improving circularity, resource-efficiency, waste management, and environmental monitoring through the use of space data, with the goal of reducing environmental impacts either directly for the company or indirectly through its products for clients. The program targets various sectors including raw materials, agriculture, energy, and logistics. The total budget allocated is €2.500.000, with up to 100 projects to be selected.

Applicants: SMEs, start-ups, scale-ups established in EU Member States or Horizon Europe associated countries

Activity sector: downstream space data and services in raw materials, agriculture, energy, and logistics

PoliRuralPlus Enhance Open Call

The Enhance Call aims to support small-scale validation projects that apply and test the JackDaw GeoAl chatbot in real European contexts. Its objectives are to demonstrate JackDaw's value in policy-making,

planning, research, and citizen engagement; collect structured feedback on usability and impact; empower local actors through capacity building in Al-based territorial analysis; and ensure replicability of innovative approaches to rural–urban development across Europe. The total budget allocated is €175.000, with up to €25.000 per project.
