CALLS FOR PROPOSALS

Attraverso i programmi europei a gestione diretta, l'UE sostiene finanziariamente lo sviluppo di progetti che contribuiscono a realizzare gli obiettivi politici della Commissione per la programmazione 21-27. Tali programmi prevedono specifiche ***call for proposals*** pubblicate e gestite direttamente dalla Commissione europea e dalle sue Agenzie esecutive. Ciascun programma può prevedere regole di candidatura distinte e

anche le modalità di gestione e rendicontazione delle attività realizzate e delle relative spese possono essere diverse.

Horizon Europe: New concepts and approaches for resilient and green freight transport and logistics networks against disruptive events (including pandemics)

New production and distribution trends (e.g. globalisation, lean manufacturing, just-in-time inventory) as well as emerging digital technologies have introduced new kinds of challenges to the supply chain. Together with resilient and smart infrastructures, new concepts, innovative solutions and better cooperation of operators are needed for freight transport to minimise the negative impacts of disruptions, shorten the recovery and ease the transition time, while taking in due account emissions and energy consumption reductions as feasible.

Horizon Europe: Innovative Health Initiative Joint Undertaking 1st call for proposal

The Innovative Health Initiative Joint Undertaking (IHI JU) is a partnership between the European Union and industry associations representing the sectors involved in healthcare. IHI first call for proposals has a total budget of 135 million euro, with 4 topics:

- Topic 1: An innovative decision-support system for improved care pathways for patients with neurodegenerative diseases and comorbidities
- Topic 2: Next generation imaging and image-guided diagnosis and therapy for cancer
- Topic 3: Personalised oncology: innovative people centred, multi-modal therapies against cancer
- Topic 4: Access and integration of heterogeneous health data for improved healthcare in disease areas of high unmet public health need

Call & Topic ID: HORIZON-JU-IHI-2022-01-single-stage

Deadline: September 20th 2022

Applicants: legal entities (public or private bodies) established in EU Member States or associated countries

Interreg Euro-MED 2022 call for Thematic Projects

The call is targeted to thematic projects focused on the “Smarter and Greener Mediterranean” programme priorities and their related specific objective. The call addresses 3 types of projects: study, test and transfer projects, with a total budget of 86 million euros. Projects have to address one of the missions tackled by the Programme: a) Strengthening an innovative sustainable economy; b) Protecting, restoring and valorising the natural environment and heritage; c) Promoting green living areas; d) Enhancing sustainable tourism.

Funding programme: Interreg Euro-Med 2021-2027

Call & Topic ID: 2nd call - Thematic Projects

Deadline: October 27th 2022

Applicants: legal entities (public or private bodies) established in the Interreg Euro-MED Programme cooperation area.

Activity sector: multiple

Partnership: required (at least 5 partners from 5 eligible regions; the lead partner must be a public body or a body governed by public law)

CASCADE FUNDING

Il supporto finanziario a parti terze o “cascade funding” è un meccanismo di finanziamento della Commissione europea attraverso cui il consorzio beneficiario è incaricato di distribuire sovvenzioni ad entità terze attraverso

le cosiddette "open calls". Accedere a una sovvenzione derivante da una open call consente di ricevere un finanziamento pubblico per eseguire specifiche attività di ricerca e innovazione (studi, esperimenti, azioni pilota) senza dover incorrere negli oneri burocratici delle tradizionali call for proposals.

InterConnect Interoperable-by-Design Prototypes Open Call

In this Interoperable-by-Design Prototypes Open Call, InterConnect is looking for Bottom-up projects that will receive up to 150.000 euro to develop and test novel Interoperable applications or services for smart homes and grids, with a clear societal and economic value. These highly innovative projects should aim to build a more comfortable and healthier living space at lower costs and enable their active participation in the energy system and market.

Deadline: July 26th 2022

Applicants: SMEs, including start-ups

Activity sector: smart living technologies

Partnership: not required

URBAN TECH Open Call

URBAN TECH supports the acceleration of competitive success of European SMEs through market launch of new or significantly improved products and services with higher value (with higher quality, increased access, eco-innovative, resource efficient and internationally scalable). URBAN TECH will provide up to 54.350€ per SME in different funding stages to develop innovative solutions to more than 300 cross-sectoral and cross-border challenges available at the URBAN TECH Online Open Space, in a Virtual Library structured around three main topics (Greentech, Health Tech and Smart City).

Deadline: September 14th 2022

Applicants: SMEs and start-ups

Activity sector: multiple (depending on single challenges)

Partnership: not required
