Horizon Europe: Work Programmes 2023-2024

The European commission has adopted the main Horizon Europe work programme 2023-24, with around €13.5 billion to support researchers and innovators in Europe to pursue breakthrough solutions for environmental, energy, digital and geopolitical challenges. Creative Europe Programme: European Cooperation Projects 2023

This action will support projects involving a large diversity of players active in different cultural and creative sectors, to carry out a broad spectrum of activities and initiatives. The action is anchored in the policy framework of the Culture strand of the Creative Europe programme and its cross-cutting issues (inclusiveness, reduction of environmental impact and gender equality). The call includes 3 topics:

Erasmus+: 2023 Calls for proposals

Erasmus+ is the EU's 2021-2027 programme to support education, training, youth and sport in Europe. With an estimated budget of €26.2 billion, it offers mobility and cooperation opportunities in higher education, vocational education and training, school education (including early childhood education and care), adult education, youth

and sport. Calls of major interest for businesses:

CASCADE FUNDING

Il supporto finanziario a parti terze o "cascade funding" è un meccanismo di finanziamento della Commissione europea attraverso cui il consorzio beneficiario è incaricato di distribuire sovvenzioni ad entità terze attraverso le cosiddette "open calls". Accedere a una sovvenzione derivante da una open call consente di ricevere un finanziamento pubblico per eseguire specifiche attività di ricerca e innovazione (studi, esperimenti, azioni pilota) senza dover incorrere negli oneri burocratici delle tradizionali call for proposals. Nella presente sezione sono riportate anche le call pubblicate nell'ambito delle KICs (Knowledge and Innovation Communities) dello European Institute of Innovation and Technology (EIT).

EMIL 1st Open call

EMIL – the European Media and Immersion Lab project, co-funded by the European Union's Horizon Europe programme - will support and execute two calls for European-based XR technology developers and content creators, providing funding in the range of 250.000-500.000€ per selected project, with an indicative duration of 15 months to ensure focused effort.

Deadline: January 31st 2023

Applicants: technology developers, media innovators, SMEs, academia from EU member states or Horizon

Europe (HE) associated countries

Activity sector: XR innovative technologies aimed at the media sector

EIT Food Open Innovation Call

EIT Food Open Innovation Call will fund collaborative food innovation projects that will put new products on the market and introduce new and improved commercial processes and services, for the benefit of all. The proposed innovative solutions are expected to result in commercially viable products and services by the end of 2024 and beyond, and work towards achieving the following goals: a) Healthier lives through food; b) A net zero food system; c) A fully transparent, fair and resilient food system. Total funding available for selected 2023 activities resulting from this call is estimated at 20 million EUR, of which 5 million EUR will be reserved for the second submission deadline in April 2023.
