## **CALLS FOR PROPOSALS**

Attraverso i programmi europei a gestione diretta, l'UE sostiene finanziariamente lo sviluppo di progetti che contribuiscono a realizzare gli <u>obiettivi politici</u> della Commissione per la programmazione 21-27. Tali programmi prevedono specifiche **calls for proposals** pubblicate e gestite direttamente dalla Commissione

europea e dalle sue Agenzie esecutive. Ciascun programma può prevedere regole di candidatura distinte e anche le modalità di gestione e rendicontazione delle attività realizzate e delle relative spese possono essere diverse.

## Interregional Innovation Investments (I3) Initiative

The Interregional innovation investments initiative as part of the European Regional and Development Fund (ERDF) aims at supporting interregional innovation projects in their commercialisation and scale-up phases giving them the tools to overcome regulatory and other barriers and bring their project to investment level. EISMEA will implement two strands of the programme:

- Financial and advisory support for investments in interregional innovation projects;
- Financial and advisory support to the development of value chains in less developed regions.

In this context, the Agency is responsible for implementing grants to support:

- Innovation Actions (IA) for mature partnerships to connect demand and supply to accelerate interregional innovation investments in Smart Specialisation priority areas.
- Simplified Innovation Actions (SIA) for less developed regions to increase the capacity of regional innovation ecosystems to participate in global value chains.

**Funding programme**: European Regional and Development Fund (ERDF)

Deadline: (Two-stage) February 1st 2022 / October 18th 2022

Applicants: legal entities (public or private bodies) established in EU member states or I3 associated countries.

**Partnership:** required; consortia should be composed of minimum 5 entities from 5 different regions in 3 eligible countries. The coordinator must be either a public body, private non-profit organisation or international organisation.

## Horizon Europe: Digital tools to support the engineering of a Circular Economy - Made in Europe Partnership (Research and Innovation Action)

The focus is on developing new concepts, methods, and digital tools to support further engineering of the industrial processes for recycling, re-manufacturing, refurbishing, and reuse of manufactured products and components. New solutions will enable remanufacturing and high-quality recycling by digitalisation of product and component information throughout the whole product lifecycle, in line with the 2020 Circular Economy Action Plan.

Call & Topic ID: Climate neutral, circular and digitised production 2022 (HORIZON-CL4-2022-TWIN-TRANSITION-01-07)

Deadline: March 30th 2022

**Applicants:** profit entities (Startups, SMEs, large companies); universities; public/private research centres; public administration; non-profit entities

Activity sector: circular manufacturing

**Partnership:** required (at least 3 independent legal entities established in different EU Member States or Horizon Europe associated countries)

# Horizon Europe: Boosting mental health in Europe in times of change (Research and Innovation Action)

The proposed research should: 1) provide a comprehensive knowledge base of how a transforming Europe can influence mental health in a fast-evolving society, especially in the most vulnerable populations, by consolidating data from relevant sources and/or acquiring new data, and by reviewing existing methodologies. 2) Develop and implement (pilot and/or scale-up) interventions, which promote wellbeing and prevent mental illness to help cope with and mitigate the stress of a changing society, including digitalisation, climate change and/or other factors.

#### **CASCADE FUNDING**

Il supporto finanziario a parti terze o "cascade funding" è un meccanismo di finanziamento della Commissione europea attraverso cui il consorzio beneficiario è incaricato di distribuire sovvenzioni ad entità terze attraverso le cosiddette "open calls". Accedere a una sovvenzione derivante da una open call consente di ricevere un finanziamento pubblico per eseguire specifiche attività di ricerca e innovazione (studi, esperimenti, azioni pilota) senza dover incorrere negli oneri burocratici delle tradizionali calls for proposals.

## **WORTH Partnership Project Open call**

WORTH Partnership Project was funded by the European Commission under COSME. The project provides companies with an incubation programme to develop new businesses, including a) 10.000 to 20.000 € in financial support; b) coaching on business strategy and technology development; c) legal advice on intellectual property rights and protection; d) participation in exhibitions; e) networking and professional links. *Deadline:* February 2<sup>nd</sup> 2022

**Applicants:** designers (fashion, product and industrial designers), crafters, SME manufacturers, tech-firms and start-ups

Activity sector: fashion and textile, footwear, fur and leather, furniture and home decoration, accessories and jewellery

Partnership: not required

## **REACH Open call for statups and SMEs**

REACH, the "euRopEAn incubator for trusted and secure data value Chains", is an Innovation Action project funded by the European Commission. REACH aims at supporting experimentations on secure and trusted data value chains across several sectors and launching of new data-fuelled products and services to the market, leveraging the capacities of the best data-driven DIHs in Europe. Over its lifetime, REACH will support +100 business ideas from SMEs and select among them 30 solid business cases through a total of three open calls, distributing a total amount of €3.5M.
