## CALLS FOR PROPOSALS

Attraverso i programmi europei a gestione diretta, l'UE sostiene finanziariamente lo sviluppo di progetti che contribuiscono a realizzare gli obiettivi politici della Commissione per la programmazione 2014-2020. Tali programmi prevedono specifiche **calls for proposals** pubblicate e gestite direttamente dalla Commissione europea e dalle sue Agenzie esecutive. Ciascun programma può prevedere regole di candidatura distinte e anche le modalità di gestione e rendicontazione delle attività realizzate e delle relative spese possono essere diverse.

### **Innovation Procurement Strategy Award**

The European Innovation Procurement Awards aim to recognise public and private buyers across Europe in their efforts to promote innovation procurement and the innovative ways the solutions are procured. It also aims to emphasise the importance of close buyer – supplier cooperation in bringing the innovative solutions to market.

**Funding programme:** Horizon Europe – European Innovation Council

**Deadline:** July 29<sup>th</sup> 2021

**Applicants:** a public and/or private procurer (including international organisations), as well as individuals/natural persons

**Activity sector:** innovation procurement

**Partnership:** not required

### **Enhancing synergies between the EIC and Startup Europe**

The financed actions will act as a catalyst to fulfil the potential of European startups, in delivering market-ready applications and technology solutions that can contribute to the competitiveness and strategic autonomy of EU industry in key technology areas and value chains.

**Funding programme:** Horizon Europe - EIC (Coordination and Support Action)

**Deadline:** September 22<sup>nd</sup> 2021

**Applicants:** Startup ecosystem builders, business angel organisations, venture capital entities, accelerators, incubators, startup associations

**Activity sector:** support services to startups

**Partnership:** optional

## CASCADE FUNDING

*Il supporto finanziario a parti terze o "cascade funding" è un meccanismo di finanziamento della Commissione europea attraverso cui il consorzio beneficiario è incaricato di distribuire sovvenzioni ad entità terze attraverso le cosiddette "open calls". Accedere a una sovvenzione derivante da una open call consente di ricevere un finanziamento pubblico per eseguire specifiche attività di ricerca e innovazione (studi, esperimenti, azioni pilota) senza dover incorrere negli oneri burocratici delle tradizionali calls for proposals.*

### **COVID-X Open Call #2**

The COVID-X project aims to provide to competitive and market oriented European SMEs access to knowledge, technology, capital and markets, with the aim to place new products and services in the market with the goals of fighting against the COVID-19 pandemic. COVID-X will fund EU Companies and Healthcare Providers to boost data-driven solutions with the power to overcome challenges in Diagnosis, Prognosis, and Follow-up.

**Deadline:** Stage 1: July 22<sup>nd</sup> 2021 / Stage 2: September 16<sup>th</sup> 2021

**Applicants:** a) Single players (EU Tech SMEs / Start-Ups) validating their solutions at one of COVID-X clinical partners or b) Team players (Tech Provider working with a Healthcare provider that will validate the solution).

**Activity sector:** digital / health

**Partnership:** optional

### **Low Carbon Business Action (LCBA) Canada Program**

This EU funded project aims at selecting EU solutions providers on low carbon and circular economy related technologies in Canada. Interested companies can submit Expressions of Interest to specific challenges, presenting their innovative solutions. Successful applicants will then be invited to pitch their solutions to the Canadian companies in September 2021.

**Deadline:** September 2021

**Applicants:** European SMEs, small Mid-Caps and mature start-ups

**Activity sector:** low carbon and circular economy

**Partnership:** not required

### **Creative Europe Programme (CREA) calls for proposals**

Following on from the previous programme, Creative Europe will keep supporting the European cultural and creative sectors for the period 2021-2027. The Programme builds on three strands – “CULTURE”, which covers cultural and creative sectors with the exception of the audiovisual sector; “MEDIA”, which covers the audiovisual sector; and the “CROSS-SECTORAL strand”, which covers activities across all cultural and creative sectors.

**Funding programme:** Creative Europe Programme (CREA)

**Planned opening date:** June 2021

**Deadline:** August / September 2021

**Applicants:** Cultural and creative organisations, cinemas, films

**Activity sector:** music, publishing, cultural heritage and architecture

**Partnership:** depending on the specific call
