




### Young entrepreneurs committee

# **CIRCULAR HEALTH - EDIH**

Since I January 2023, together with University of Turin and other excellent local partners, we have been participating in the European Digital Innovation Hub for Circular Health - CHEDIH project -, promoted by the European Commission and the Ministry of Enterprises and Made in Italy with the aim of accelerating digitization of companies and the Public Administration.

CHEDIH addresses companies in the **health and agrifood supply chains** located in **Piedmont and Valle d'Aosta**, and interacts with the European EDIH
network for the pooling of respective skills and with
the already existing European networks – such as the
Enterprise Europe Network – for the activation of
appropriate synergies.

In the context of the "Digital Europe

Programme", the construction of European Digital Innovation Hubs - EDIHs is envisaged, in order to support the digital transformation of European societies and economies, ensuring the digital transition of the European industry with particular reference to SMEs and public administration through the adoption of advanced digital technologies, Artificial Intelligence, High Performance Calculation, Information Security.

EDIHs are selected according to a double European and national procedure and are financed by the European Commission and by national funds.
